Vision for the NP	By 2035 the unique rural landscape of Cliffe and Cliffe Wood Parish will continue to be a haven for wildlife and agriculture, and provide homes, jobs and community infrastructure for people by protecting the heritage of the area and enhancing its character through sustainable development.”				
H1	The NP proposes that any new development that comes forward on greenfield sites should not just be for one use, e.g. housing, but must include other land uses				
INFRA4	The NP proposes that any new development that comes forward will provide sufficient parking (including for cycles) on site so that on street parking will not be increased as a result of development				
SUSDEV4, H5, E&H4	The NP proposes that any new development that comes forward follows specific design guidelines that ensure that it is sensitive to the rural setting, appropriate materials and maintain an open feel in each village				
H6, H7	The NP proposes that any new housing development that comes forward must meet local housing need (for bungalows and small family accommodation) and be developed at low density (i.e. not too many homes on each site)				
SUSDEV5	The NP proposes that any new major development proposals be supported by an “Infrastructure Sufficiency Statement” which shows, supported by evidence, that there are sufficient transport health and education facilities to support the proposals				
E&H2	The NP proposes that all development will be expected to protect and enhance biodiversity				
E&H3	The NP proposes that all development proposals will be expected to be supported by heritage investigations to ensure that no heritage assets or lost or left undiscovered by development
