1.0 Apologies for Absence

- 2.0 **Declarations of Interest** Disclosable Pecuniary Interests under the Code of Conduct for Parish Councils. A councillor, who declares a pecuniary interest may not participate in discussion or vote on the matter. If an interest is not declared at the outset of the meeting, it should be disclosed as soon as the interest becomes apparent. Dispensation may be requested in writing to the Clerk (Proper Officer) who under certain circumstances will allow a councillor to speak and vote on the matter.
- 3.0 **Co-Option** There are currently two vacancies in the Cliffe Woods Ward following a resignation and an exclusion due to non-attendance. Both vacancies have been advertised and there was no call for election in the statutory period so the council can proceed to co-option.

Concern has been raised by councillors and residents following the death of a young Cliffe Woods teacher on Station Road in Cliffe. A memorial (format to be agreed, possibly a bench) is being planned at or near the school. Road safety issues to be raised with Medway Council Highways/Ward Councillors. It is possible that the speed limit could be reduced in that area by extending the limit south from the Cliffe direction, but enforcement will still remain an issue. Street lighting could be considered but there is a lack of dwellings in that location and it is outside the core village area.

- a) **Trenport Land** Cliffe –No Planning submission yet. There is a risk of this site being added to approved sites in the Local Plan because of removal elsewhere.
- b) Simpkins- MC/19/2836 (MC/16/3742) Remaining reserved matters (appearance, landscaping, layout, and scale for the 50 Retirement homes (approved on appeal at outline stage) refused by Medway Planning appeal to be decided on written representations awaiting update. (St Helens Meadow). A further application received on the site MC/21/3380 Outline application with some matters reserved (appearance, landscaping, layout and scale) for construction of nine detached houses.
- c) MC/21/1287 Redrow(Gladmans) site West of Town Road Changes have been made following representations – 138 Private/48 Affordable, 184 Total (was up to 225), 3 Storey reduced to 2.5, no pedestrian access through Ladyclose/Mortimers.
- d) Esquire- MC/21/1694 (Orchard) South of View Road No further information or date for decision.
- e) **Draft Medway Local Plan** awaiting update as publication of Draft and Public Consultation has been postponed to late February 2022.
